- A. MEMBERSHIP DUES ARE **NON-REFUNDABLE**. ALL MEMBERSHIPS RUN FROM JANUARY 1 AND WILL EXPIRE ON THE LAST DAY OF THE YEAR.

- C. MEMBERSHIP CARDS ARE ISSUED TO ALL MEMBERS IN GOOD STANDING, AND ARE **NON-TRANSFERABLE**. MEMBERSHIP PRIVILEGES MAY BE REVOKED OR SUSPENDED AT THE DISCRETION OF THE INTERNATIONAL CLUB DUE TO NON-COMPLIANCE OF THE RULES AND REGULATIONS, OR IN THE EVENT OF ANY MEMBER CONDUCT THAT IS DEEMED INAPPROPRIATE OR DISRUPTIVE.
- D. MEMBERS MAY HAVE GUESTS PLAY FOR THE ACCOMPANIED GUEST OF MEMBER RATE. **MEMBERS MUST ACCOMPANY THEIR GUESTS IN ORDER TO QUALIFY FOR THIS DISCOUNTED RATE**. MEMBERS MAY BOOK STARTING TIMES WITH NO ADVANCE STARTING TIME RESTRICTIONS IF THEY BRING AN EQUIVALENT (OR BETTER) NUMBER OF PAYING GUESTS. INTERNATIONAL CLUB RESERVES THE RIGHT TO LIMIT THE NUMBER OF GUESTS THAT A MEMBER MAY BRING.
- E. **ANY MEMBER THAT FAILS TO SHOW UP FOR, OR PROPERLY CANCEL THEIR STARTING TIME, WILL BE CHARGED THE FULL VALUE OF THE STARTING TIME ON THEIR MEMBER ACCOUNT. ANY MEMBER THAT BOOKS TIMES IN ADVANCE FOR THEMSELVES AND GUESTS AND FAILS TO SHOW UP WITH THE APPROPRIATE NUMBER OF GUESTS WILL BE CHARGED THE FULL VALUE OF THE STARTING TIME(S) THAT THEY BOOKED.**
- F. MEMBERS ARE NOT ELIGIBLE FOR ANY INTERNATIONAL CLUB PROMOTIONS OTHER THAN THOSE THAT ARE SPECIFICALLY IDENTIFIED AS BEING FOR INTERNATIONAL CLUB MEMBERS.
- G. AT THE END OF EVERY MONTH YOU WILL BE EMAILED A STATEMENT SHOWING HOW MANY ROUNDS WERE PLAYED THAT MONTH.
